

PRODUCTS CONTAINING DIMETHOATE

PERMIT TO ALLOW POSSESSION, SUPPLY AND USE OF SUSPENDED HOME GARDEN PRODUCTS CONTAINING DIMETHOATE THAT ARE OR REGISTERED HOME GARDEN PRODUCTS CONTAINING DIMETHOATE THAT BEAR SUSPENDED OR CANCELLED LABELS

PERMIT NUMBER – PER 13156

This permit is issued under s.114(1) and (3) of the Agvet Codes at the APVMA's initiative following the APVMA action to suspend all products containing dimethoate on 06 October 2011. Any person dealing with suspended or registered dimethoate products that bear suspended or cancelled labels or purporting to use this permit must comply with all requirements as specified in the Agvet Code of their State.

This permit is issued subject to the condition that any person using, or purporting to use, this permit must do so in accordance with the conditions set out in parts 1 to 5 of this permit.

WARNING:

The registration and/or label approvals of the products listed in Attachment 1 are not in force during the period of suspension.

A person must not possess with the intent to supply or deal with any of the suspended products or registered products bearing suspended or cancelled labels during the suspension period, except in accordance with instructions issued by the APVMA. A failure to comply with the instructions issued by the APVMA may result in an offence against the Agvet Codes and compliance action being taken.

Suppliers should also note that it is an offence to advertise these suspended products or promote the use of these suspended products during the period of the suspension other than for the purpose of advising users of the new instructions.

CONDITIONS OF THIS PERMIT

PERSON AUTHORISED

1. Persons who can use the product under this permit:

Persons generally.

DURATION

2. THIS PERMIT IS IN FORCE FROM 6 OCTOBER 2011 UNTIL 5 OCTOBER 2014

JURISDICTION

3. ALL STATES

PRODUCTS

4. This permit applies to the suspended or registered products that contain dimethoate, bearing suspended or cancelled labels, for home garden uses as specified in Attachment 1.

CONDITIONS OF POSSESSION, SUPPLY AND USE

5. Permitted Dealings

Possession and custody:

A person may possess, have custody of, use or otherwise deal with the suspended dimethoate products (and products bearing a suspended or cancelled label) only in accordance with the instructions in Attachment 2 of this permit.

Users:

PERSONS who wish to use products containing dimethoate that are suspended or bear a suspended or cancelled label must read, or have read to them, the instructions included in Attachment 2 of this permit. Users who have had the instructions read to them must confirm to the reader that they understand the instructions.

Suppliers:

All suppliers must at the time of the supply of a product covered by this permit, provide to the person taking responsibility for the supplied product:

- a copy of this permit in full setting out the conditions and instructions for use, and
- supply product with a copy of the instructions in Attachment 2 of this permit securely affixed to each container of product.

Registrants:

All registrants must maintain records of product supplied under this permit. Specifically the records must include the quantity and dates of product supplied, the names and addresses of the persons supplied product and confirmation that at the time of supply of the product a copy of the instructions in Attachment 2 of this permit was securely affixed to all containers. The records must be progressively maintained whilst the permit is in force and retained for a minimum period of two years from the date of expiry of this permit. Records must be made available to the APVMA upon request.

ATTACHMENT 2: INSTRUCTIONS FOR SUPPLY AND USE OF SUSPENDED PRODUCTS AND REGISTERED PRODUCTS BEARING SUSPENDED OR CANCELLED LABELS

These instructions apply to the possession, supply and use of home garden products containing dimethoate that are suspended or are registered and bear suspended or cancelled labels (as listed in Attachment1) during the period of suspension.

Possession and custody

A person may possess, have custody of, use or otherwise deal with the suspended dimethoate products (or registered products bearing a suspended or cancelled label) only in accordance with these instructions.

Supply

All suppliers must, at the time of the supply of a product covered by this permit (bearing a suspended or cancelled label), provide to the person taking responsibility for the supplied product:

- a copy of this permit in full setting out the conditions and instructions for use, and
- supply product with a copy of these instructions securely affixed to each container of product.

Use

Product can only be used in accordance with the instructions contained in this permit during the period of suspension.

READ THESE INSTRUCTIONS before using or otherwise handling the product.

When using or otherwise handling the product, follow these instructions.

When using or otherwise handling the product, follow the instructions of the current label except as follows:

Prohibited Crop Uses

The current (suspended) label may include instructions for use on fruit trees and vegetables. The use of dimethoate on these crops is no longer approved and the following restraint applies.

DO NOT apply to food producing plants in the Home Garden

ATTACHMENT 3: PERMITTED USES OF PRODUCTS LISTED IN ATTACHMENT 1

In addition to the instructions below the products must be used in accordance with the instructions on the label attached to the container.

Ornamentals and Flowers only	Aphids, thrips, bean fly, leaf miners, tomato mite, jassids, mealy bug, azalea lace bug, green vegetable bug, bronze orange bug, white fly Rutherglen bug,	Hold can 30cm from plant and spray to just wet all surfaces	Apply when pests first appear and repeat at 10 – 14 day intervals, or on reinfestation.

Crop	Pests Controlled	Application instructions	Comment
Ornamentals and Flowers	Aphids, thrips, bean fly, leaf miners, jassids, tomato mite, mealy bug, azalea lace bug, green vegetable bug, bronze orange bug. (not in Tas)	10 mL/10 L of water	Apply as a spray when pests first appear and repeat at 10 to 14 day intervals, or on reinfestation.
