On 15 May 2024, Elanco Australasia Pty Ltd [ABN: 64 076 745 198] initiated a voluntary recall under section 106 of the Agricultural and Veterinary Chemicals Code Scheduled to the Agricultural and Veterinary Chemicals Code Act 1994 (Cth) in relation to the chemical product described above.

### Reason for voluntary recall

There have been some reports of issues in resuspending the powder in diluent resulting in large particles of undissolved powder. This recall is limited to the above-mentioned batch numbers.

### Hazard

Inability to withdraw the re-suspended product from the vial may lead to lower dosing and possible lack of efficacy.

## What to do if in possession of this chemical product

Do not use Penethaject Antibiotic Injection from batch NZ45969 (powder) E101591 (cow 6 pack).
