The *Agricultural and Veterinary Chemical Code Act 1994* (the Act) commenced on 15 March 1995. The Agricultural and Veterinary Chemicals Code (the Agvet Code) scheduled to the Act requires notices to be published in the *Gazette* containing details of the registration of agricultural and veterinary chemical products and other approvals granted by the Australian Pesticides and Veterinary Medicines Authority. The Agvet Code and related legislation also requires certain other notices to be published in the *Gazette*. A reference to Agvet Codes in this publication is a reference to the Agvet Code in each state and territory jurisdiction.

The APVMA Gazette is published fortnightly and contains details of the registration of agricultural and veterinary chemicals products and other approvals granted by the APVMA, notices as required by the Agricultural and Veterinary Chemicals Code (the Agvet Code) and related legislation and a range of regulatory material issued by the APVMA.

Pursuant to section 8J(1) of the Agvet Code, the APVMA has decided that it is unnecessary to publish details of applications made for the purpose of notifying minor variations to registration details. The APVMA will however report notifications activity in quarterly statistical reports.

On 8 June 2022, Intervet Australia Pty Limited (ABN: 79 008 467 034) initiated a voluntary recall under section 106 of the Agricultural and Veterinary Chemicals Code scheduled to the *Agricultural and Veterinary Chemicals Code Act 1994* (Cth) in relation to the chemical product described above.

### Reason for voluntary recall

This is not a product nor a batch recall.

This is a notification to customers of a label misprint. Customers are not required to return affected units.

The label on the outer packaging of the affected batch shows the incorrect APVMA registration number 47258 has been printed in place of 47248.

### Hazard

None.

### What to do if in possession of this chemical product

No specific actions are required other than to note the correct APVMA registration number is 47248.
