



Confidential commercial information statement

As part of the application process, you have the option to alert the APVMA to information that you consider may be commercially sensitive. Under the Agvet Code, the APVMA has an obligation not to disclose confidential commercial information (CCI).

Instructions for completing the table

Please complete a separate line for each piece of information and complete all four columns.

- **Column 1 – Data Item name:** Please include sufficient details to allow the APVMA to clearly identify the information that is being claimed as CCI. Do not include information which is publicly available (ie not confidential) or is not about an active or non-active constituent or a chemical product.
- **Column 2 – Type of CCI:** Indicate the reason(s) why you consider that the information meets the definition of CCI by selecting the box. If none of the boxes apply, the information is not CCI and should not be included in this form.
- **Column 3 – Authorising Party for the CCI:** This means the person to whom the information is confidential. It may be you, or another entity which has allowed you to provide the information to the APVMA.
- **Column 4 – Proposed Period of Confidentiality:** Information does not necessarily remain as CCI indefinitely. If it is made public, or no longer has a commercial or other value in being kept confidential, the information will no longer be CCI and the restrictions on disclosure will not apply. You should indicate the period of confidentiality (eg five years). If this is not known or cannot be estimated, insert 'unknown'.
