



## **REGISTRATION STATISTICS 2011/12**

The following tables and graphs set out registration statistics for the financial year 2011/12 for the Veterinary Medicines Program.

### **Tables**

The 25 application categories are aggregated into statutory\* timeframe periods.

#### *Preliminary assessment*

Preliminary assessment is the correct legal term for what is more commonly known as 'screening'.

This table shows:

- applications in process from the previous year;
- applications received in 2011/12; and
- applications withdrawn or rejected during the screening process.

#### *Outcome of application*

This table shows the number of applications received for assessment and the number finalised during 2011/12.

#### *Summary (Determination all applications)*

This table shows a summary of all applications, at screening and evaluation, finalised during 2011/12. The table includes the average clock ON time (the time the APVMA has been evaluating the application) and the average elapsed time (the total time to finalise the application, i.e. time the APVMA evaluates the application, plus the time taken by the applicant to correct defects and supply the label for approval).

### **Graphs**

The graphs are divided into timeframe periods for application categories. Each graph shows the number of applications that were finalised within 20% to 120% of the application statutory timeframe.

Note that if an application has been withdrawn during screening or is a modular application without a timeframe it will be counted in the 2 to 3 month application graph.

\* The statutory timeframe for each application category is defined in Schedule 6 of the *Agricultural and Veterinary Chemicals Code Regulations 1995*.

13 to 15 month = Cat 2, 10

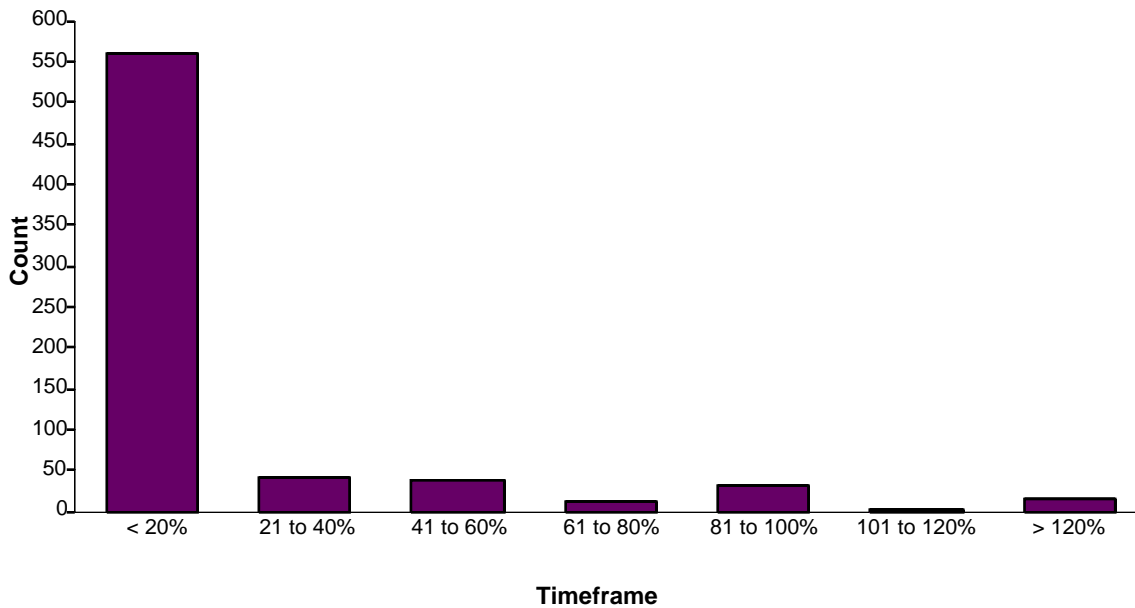

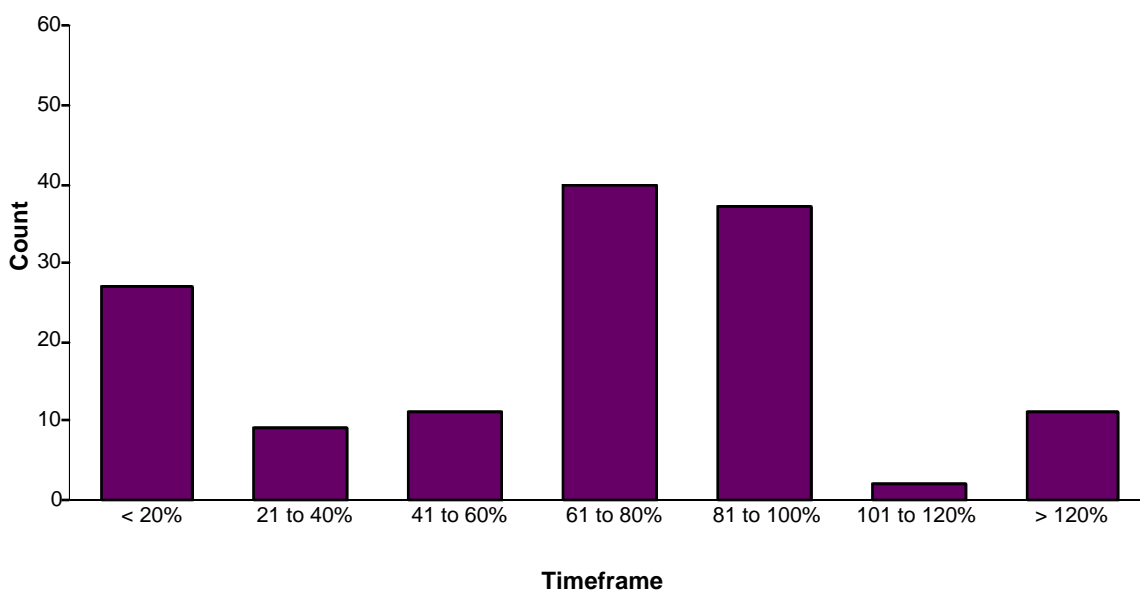

**Total finalised: 705**



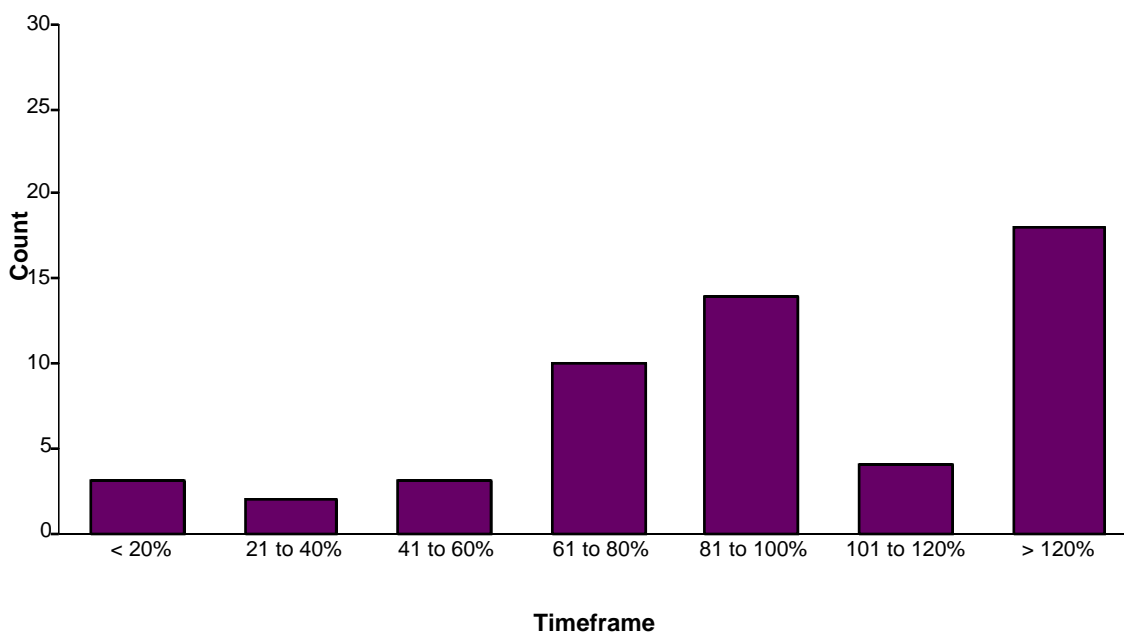
**5 month applications**

**Total finalised: 137**



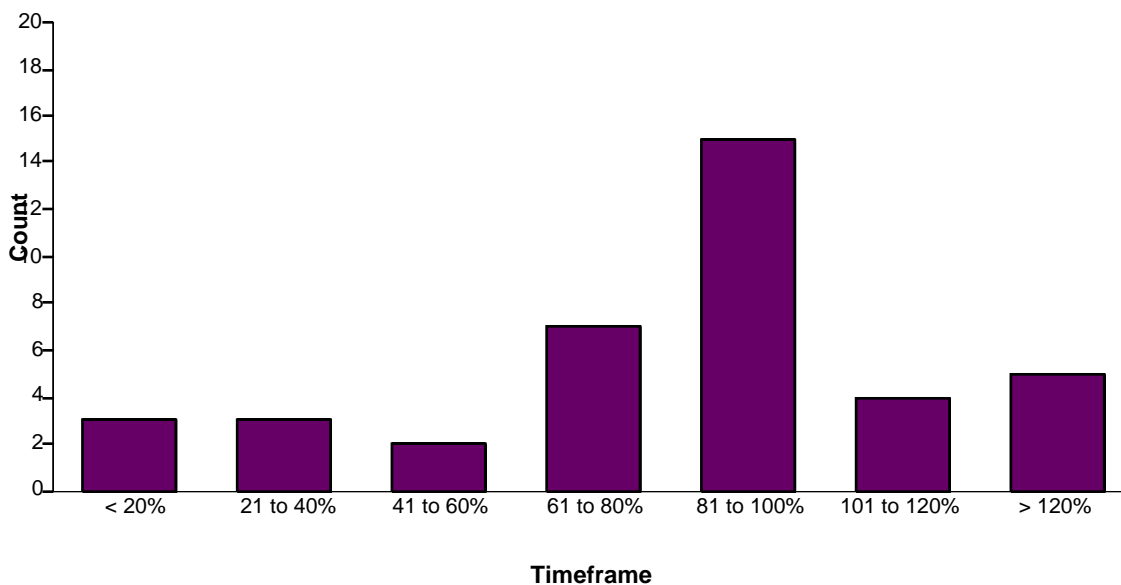
**6 to 8 month applications**
