The Agricultural and Veterinary Chemical Code Act 1994 (the Act) commenced on 15 March 1995. The Agricultural and Veterinary Chemicals Code (the Agvet Code) scheduled to the Act requires notices to be published in the *Gazette* containing details of the registration of agricultural and veterinary chemical products and other approvals granted by the Australian Pesticides and Veterinary Medicines Authority. The Agvet Code and related legislation also requires certain other notices to be published in the *Gazette*. A reference to Agvet Codes in this publication is a reference to the Agvet Code in each state and territory jurisdiction.

Levy payment for the 2019–20 financial year

In accordance with section 6(1)(d) of the *Agricultural and Veterinary Chemical Products (Collection of Levy) Act 1994* (**Collection of Levy Act**), the Australian Pesticides and Veterinary Medicines Authority (**APVMA**) makes the following direction in respect of the amount of levy payable by the liable person under section 16 of the Collection of Levy Act for the 2019–20 financial year.

PAYMENT BY INSTALMENT

For the purposes of section 6(1)(d) of the Collection of Levy Act, the APVMA directs that the amount of levy payable as assessed under section 16 of the Collection of Levy Act and notified to the liable person in the Notice of Assessment for the 2019–20 financial year may be paid by instalments as follows:

Date	Amount of Levy to be paid
15 January 2021	No less than 50% of the amount of levy payable as assessed in the Notice of Assessment for the 2019–20 financial year
15 June 2021	The balance of the amount of levy payable as assessed in the Notice of Assessment for the 2019–20 financial year

The APVMA directs that the amount of levy that would be required to be paid by the due date as specified in the Notice of Assessment for the 2019–20 financial year is taken to have been paid by that date if the levy is paid in instalments as set out above.
